Hi Gary,

We spoke to Ms. James and Ms. Patterson, and they are declining to provide interviews given that the City will not release the background information they have requested.

Regarding additional evidence/witnesses, we think we referenced much of it in the complaint, as well as in the tort claim we just shared with you. As a companion to that, I. am attaching the letter Jim sent to SPPD last August on behalf of Ms. James and Ms. Patterson.

We are assuming you can obtain the referenced evidence (videos and our clients and others provided SPPD, email correspondence, social media screenshots, etc.) from SPPD directly. But if there is anything specific you cannot obtain from them, we would be happy to provide you what we have.
