Dear Mayor Joe and Councilmembers:

We submit this letter of concern as organizations representing residents of South Pasadena and organizations advocating for the civil rights of our communities. We demand a formal investigation from the City Council into the recent decision of the Chief of Police to approve and promote a public event led by a local chapter of the American Society for the Defense of Tradition, Family, and Property, scheduled to be held at the South Pasadena Police Department station on Saturday, September 26, at 10:00 am. This letter also serves as a personnel complaint against Chief Ortiz submitted under Section 320.2.2. of the South Pasadena Police Department Policies and Procedures Manual.

Chief Joe Ortiz sent an email, with the subject line, "Invitation to all," to undisclosed recipients on September 24, 2020, at around 2:55 pm. Chief Ortiz described the event as "an excellent opportunity to meet with some of our community members who want to show their support and publicly recognize all first responders and the excellent work we do." Chief Ortiz noted that, "please know that our uniformed personnel are not in attendance to endorse, support, oppose or contradict any political campaign, initiative, social issue, cause, or religion. *Please refrain from using photos of our personnel as we welcome the community's spiritual support.*"

That evening, at around 5:58 pm, Chief Ortiz sent an email to several city email inboxes and individuals informing them that the event "has been postponed until further notice."

The next day, the City Manager's office issued a statement from Chief Ortiz apologizing for his actions. Chief Ortiz stated: "My error in judgment was the result of good intentions, albeit with poor execution. I deeply regret that my lack of due diligence in this matter has caused confusion and doubt about the many great qualities of our community that make it so special."

Chief Ortiz's invitation of a group espousing racism, bigotry and xenophobia to gather on city property is a breach of our trust and confidence. At a minimum, the City Council must investigate this incident. The American Society for the Defense of Tradition, Family, and Property (TFP) is a religiously-affiliated organization that promotes hate ideology, speech, and actions. On their website, TFP has a page dedicated to "Pray for Your Police Department." On that same page, TFP suggests the disproportionate number of Black lives killed during police encounters is justified. The TFP website contains numerous

articles denouncing Black Lives Matter protests,² the movement for racial justice,³ and public health measures taken during this COVID-19 pandemic.⁴ TFP's articles call the coronavirus "the Chinese virus."⁵ They characterize community-based organizations and leaders "mythical" and indigenous communities and communities of color as "not exist[ing] as unified social units."⁶ The Southern Poverty Law Center describes TFP as a "virulently anti-LGBT group."⁷

Chief Ortiz's claim that he was unaware of the hateful views TFP prominently displays on its website defies credulity. What kind of diligence Chief Ortiz did exercise in sanctioning the TFP event? If Chief Ortiz did not know that TFP promotes positions at odds with South Pasadena's inclusive values, why did he caution attendees not to take photos of officers and staff taking part in the prayer? What misuse of public funds, public property, and email systems occurred? Do these actions amount to violations of the department's own policies and state laws? Is this misconduct subject to discipline?

Chief Ortiz's invitation to host TFP at the police department must be examined in context. Since May of this year, South Pasadena Youth for Police Reform and Black Lives Matter South Pasadena have been demonstrating on our streets calling for police reform and justice for the Black lives lost to police brutality. The Anti-Racism Committee of South Pasadena held a listening session with the police department and the City Council to share their personal experiences of biased and unequal treatment by police officers. Care First South Pasadena has called for our city leaders to critically examine the police budget. These public demands for police reform are occurring front and center in our city and in cities throughout our country. While our views may differ on the specifics of police reform, we share one vision: a community that respects the dignity and safety of all people. And when we dissent, we do so respectfully—not with hate.

Chief Ortiz's decision to align the police department with TFP has harmed our community. As such, the City Council must act swiftly to investigate this incident. We request that this incident be discussed as an agenda item at the next City Council meeting on **October 7 or at a special meeting called by the council**. Should there be costs to complete an investigation, Councilmembers may consider using their discretionary district funds to supplement some of these costs.

This City Council passed Resolution 7673 in August 2020 affirming the city's commitment to safeguarding the civil rights, safety, and dignity of all our residents and to *proactively* ensure our rights and privileges. The city has pledged to not tolerate any acts of discrimination motivated by hatred

Thank you for the responding to my e-mail. As you might have heard at last week's city council meeting, many residents are not satisfied with the chief's apology. For starters, the letter of apology released by the chief did not indicate the prayer event with ATFP was canceled, it stated it was postponed. Earlier this summer, Cpl Randy Wise accused London Lang of bringing hate to our city. Cpl Wise's comments were recorded and viewed by many residents. Generally speaking, the BLM protesters have acted responsibly, thery were protsting/responding to the national conversation following the murder of George Floyd, their protest was not directed at SPPD, but police culture and practices in general.

Incidents such as the one with Cpl Wise and the Chief have caused SPY4PR (So Pas Youth 4 Police Reform), BLM, the SPHS Anti-Bias Club and the South Pasadena Anti-Racist Committee to turn their attention inwards towards SPPD. Within the last three weeks, a SPPD officer printed out a copy of the city's signage policy and gave it to Fahren James and saying the BLM signs violated the city policy. Aside from the fact that political speech is free speech and the BLM protesters were in complince with the city ordinance, this action by the officer could be perceived as intimidating. I can get you the name of the officer if requested.

In the week following the AFTP gaffe, a resident felt it was his right to drive his vehicle up on the sidewalk threatening to harm to Fahren James. I have seen the security video from Starbucks, there is no mistaking the driver made a deliberate left turn off FairOaks on to the sidewalk in front of Starbucks and not a normal left turn into the westbound traffic lanes of Mission Street. I am not qualified to say if Mr. Cheney should have been cited for driving for not controlling his vehicle and driving onto the sidewalk, or if he should have been arrested for attempted assualt with a hate crime charge. SPPD detectives conducted an investigation and forwarded their report to the District Attorney. It is outside my level of expertise to know if Mr. Cheney was treated any differently than if a black suspect had done the same thing against a white victim, but that is the allegation a number of residents are now suggestting.

As City Manger, I respect your decision to not add this topic to the agenda. In the alternative, the city council has a police reform sub-committee which had one meeting in July and nothing since. Perhaps a discussion on this can be directed to the sub-committee. As I indicated my e-mail earlier today, this issue will not go away, nor Chief Ortiz able to perform his job effectively, while this cloud is hanging over the department and the city does not make the chief available in a public forum.

Without delving too deeply into national politics, there seems to be a similarity/causal proixmity to the AFTP gaffe by the chief to the assualt by Mr. Cheney. Similar types of assaults have occurred nationally after tweets and comments made by the President. The BLM protesters have not brought hate to our city, but instead exposed existing white supremacist and racist residents in out city and possibly within SPPD. I can't speak for them, but in a town hall with Marina Kubesrian before she resigned, members of Vecinos

Seperately, my request for a hate crime report from SPPD for the upcoming meeting still stands. Under the previous leadership city leadership, Stephanie & Marina), trust, integrity and transparency have been detroyed in the city. The Measure U committe is/has been very concerned about the cumulative effects of events over the last 3 -18 months and that the measure will be defeated. The sooner the city 'opens it coat,' the sooner the city can heal and move forward. Sort of like peeling off a band-aid, do it quick and it stings a little, peel it slowly and the agony lasts longer.

We haven't had a chance to meet in person yet, but I'm deeply disturbed that the PSC agenda for next Monday does not include a report/explanation from Chief Ortiz about the AFTP gaffe and a report on hate incidents in the city since the begiinning of the year (pre-covid, covid, and post George Floyd) I am aware of half a dozen incidents and beleive it is the responsibility of the Public Safety Commission to have a report and discussion on behalf of the community.

I appreciate there is a lot on your plate trying to clean the mess handed you and run the city at the same time. I've made this request twice in the last two weeks, including copying Chief Ortiz to make him aware of my agenda request and all I've heard back from anyone is crickets.

At last week's council meeting, there were numerous public comments about how the entire ATFP event was planned and how the city became invovled. Many public commenters called for Chief Ortiz to be fired. I'm strongly in the camp of innocent until proven guilty and sometimes people

make mistakes, which they hopefully learn from. IMHO, the quickest way to nip this incident is to agendize it, have a public discussion, and allow the chief to explain what happened.
